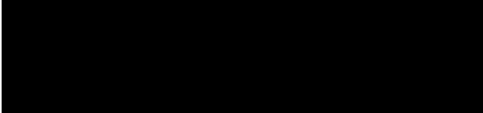

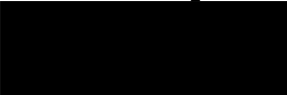

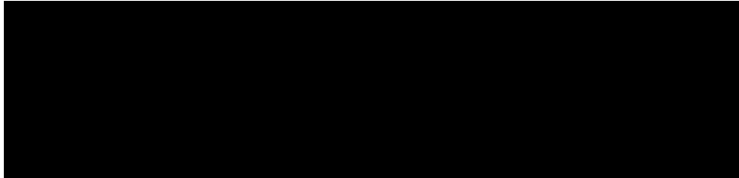
46A: Documents Required

1. MULTIMODAL BILLS OF LADING MARKED FREIGHT PREPAID CONSIGNED TO THE ORDER OF GENERAL EQUITY, LEVEL 4, GENERAL EQUITY HOUSE, 17 ALBERT STREET AUCKLAND 1010, NEW ZEALAND AND ALSO NOTIFY THE APPLICANT.
2. SIGNED COMMERCIAL INVOICE IN 1 ORIGINAL AND 3 COPIES.
3. PACKING LIST IN 1 ORIGINAL AND 3 COPIES.
4. CERTIFICATE OF ORIGIN IN 1 ORIGINAL AND 3 COPIES
